Alberta Health Services * All food vendors must provide an Alberta Health Services approved and provide copy of insurance. Alberta Health Services Inspectors will be in contact to ensure all safety standards are adhered to. All instructions and advisements by the Health Inspector must be adhered to. To not do so is grounds for removal from the Festival. * All food vendors are required to have a fire extinguisher at their truck certified within the last year. Proof of certification must be affixed to the unit or available upon request. * No barbeques are allowed under tents and all propane must be securely stored.								
Staff and Vendor Onsite								
* All Vendor employees must be at least 15 years of age, under Provincial Law. Any person left in charge of a booth must at least 18 years of age. If the owner, or person signing the Vendor Contract will not be on site daily at the Festival, the name of the person responsible for the booth, as designated by the licensee, must be made available to the Volunteer festival personnel found at the information booth.								
Loadout Schedule								
* All Vendors and equipment must be off site by 7 PM as of Sunday. Site must be left clean and free of garbage and debris. Failure to comply will result in a fine of \$200.00, and all materials left on site will be removed at the expense of the owner.
